# As we get closer to the muskie opener, here is a little background about those toothy critters.

Michigan is home to two strains of muskellunge - the Great Lakes muskellunge and the northern muskellunge. Naturally-reproducing populations of northern muskellunge are located primarily in the western Upper Peninsula, but they have been stocked in numerous lakes statewide. Northern strain muskellunge were the primary strain stocked in Michigan until 2011 when the State shifted to raising only Great Lakes strain muskellunge. Still, northern strain fish are occasionally stocked through cooperative arrangements with other states and muskellunge organizations. Naturally-reproducing populations of Great Lakes muskellunge exist in the Great Lakes and various connected waters, and they are also stocked into inland lakes and rivers where they typically do not naturally reproduce. Tiger muskellunge, a hybrid between northern pike and muskellunge, were once stocked in Michigan, but no longer are raised in state fish hatcheries. Naturally-produced tiger muskellunge are rarely caught, though they are more prevalent in lakes with high abundance of northern pike. Inland lakes in Michigan reserved as broodstock waters include Thornapple Lake in Barry County, Lake Diane in Hillsdale County, and Lake Hudson (northern strain) in Lenawee County.

Michigan's Great Lakes muskellunge are most common in Lake St. Clair and the Detroit River, which feature world-class fisheries for the large, toothy predators. Lake St. Clair has a fairly large fleet of charter boats that target muskellunge by trolling, and a growing contingent of small boat anglers that cast or jig for them as well. Because the St. Clair system is fed by cold, Great Lakes water, the muskellunge season does not open until the first Saturday of June and runs through Dec. 15. Elsewhere, for many waters the fishing season mimics the walleye season, while there are a few select waters with special regulations.

Often called "the fish of a thousand casts," muskellunge are hard to come by; they are slow to mature and take many years to reach the minimum legal size of 42 inches. Legal-sized muskellunge are rarely caught by anglers who are not fishing specifically for them; because of their large size and sharp teeth, they often break lines. Usually found in shallow weedy lakes and rivers with log jams and fallen timber, muskellunge retreat into deeper water during the heat of the summer. They can be caught by casting or trolling with very large plugs, spoons and spinners -- usually behind a wire leader -- that are retrieved or trolled at a fast rate or by bait anglers using large suckers. Though primarily fish eaters, muskellunge will take waterfowl or rodents when available.

## MUCC Corner...

NRC Approves Year-Round Coyote Season

The Natural Resources Commission unanimously approved an amendment to the Wildlife Conservation Order to allow year-round coyote hunting and allowing the use of #3 and #4 buckshot at night. Both were MUCC resolutions sponsored by the Michigan Trappers and Predator Callers Association. Special recognition is due to MTPCA president Dale Hendershot and past president John Caretti, who have testified at the NRC on behalf of their organization urging consideration and adoption of these provisions for years. MUCC also testified in support of the provisions.

The new coyote regulations expand daytime coyote hunting year round, nighttime coyote hunting with an artificial light year round, and includes the use of #3 and #4 buckshot. However, it's important to note that the quiet period restricting the use of hounds to hunt coyotes between April 16 and July 7 is maintained, and the order did not affect coyote trapping regulations.

In recent results from the Michigan Predator-Prey Study in the Upper Peninsula, coyotes had more impact on deer than other predator species in the study area, accounting for 22% of the identifiable deer kills in the study area. However, that is one factor of many factors, including habitat, that affect deer populations. The expanded regulations aren't expected, nor designed, to be a solution to the coyote problem or deer numbers on their own. It's simply another tool in the toolbox that hunters can use to more effectively manage coyotes in their local areas.

Still, this is a significant expansion of hunting opportunity. The Humane Society of the United States fought against these changes, testifying at multiple NRC meetings against them and using many of the same misleading and outright untrue arguments that they use in every attack on expanded hunting opportunities, from wolves to urban and suburban deer. But sound science won the day; even they couldn't argue that this change will negatively impact the hunted species.

And it's always a good thing when sound science beats HSUS.




















# Heart Attack: First Aid

We are in the beginning stages of organizing a certified CPR and First Aid class that is American Heart Assoc. approved this Spring. We will keep you abreast of the time and date. This will count for USCG captain requirements and healthcare worker requirements.

Someone having a heart attack may experience any or all of the following:

- Uncomfortable pressure, fullness or squeezing pain in the center of the chest
- Discomfort or pain spreading beyond the chest to the shoulders, neck, jaw, teeth, or one or both arms, or occasionally upper abdomen
- Shortness of breath
- Lightheadedness, dizziness, fainting
- Sweating
- Nausea
- A heart attack generally causes chest pain for more than 15 minutes, but it can also have no symptoms at all. Many people who experience a heart attack have warning signs hours, days or weeks in advance.

What to do if you or someone else may be having a heart attack

- Call 911 or your local medical emergency number. Don't ignore or attempt to tough out the symptoms of a heart attack for more than five minutes. If you don't have access to emergency medical services, have a neighbor or a friend drive you to the nearest hospital. Drive yourself only as a last resort, and realize that it places you and others at risk when you drive under these circumstances.
- Chew and swallow an aspirin, unless you are allergic to aspirin or have been told by your doctor never to take aspirin. But seek emergency help first, such as calling 911.
- Take nitroglycerin, if prescribed. If you think you're having a heart attack and your doctor
  has previously prescribed nitroglycerin for you, take it as directed. Do not take anyone
  else's nitroglycerin, because that could put you in more danger.
- Begin CPR if the person is unconscious. If you're with a person who might be having a heart attack and he or she is unconscious, tell the 911 dispatcher or another emergency medical specialist. You may be advised to begin cardiopulmonary resuscitation (CPR). If you haven't received CPR training, doctors recommend skipping mouth-to-mouth rescue breathing and performing only chest compressions (about 100 per minute). The dispatcher can instruct you in the proper procedures until help arrives.
- If an automated external defibrillator (AED) is available and the person is unconscious, begin CPR while the device is retrieved and set up. Attach the device and follow instructions that will be provided by the AED after it has evaluated the person's condition.

## Gunflint Lodge Walleye

#### Prep Time 15 min Cook Time 15 min

Ingredients 1/4 cup butter

- 2 3 large garlic cloves, finely chopped
- 1 2 teaspoon fresh lemon juice
- 2 1/2 lbs boneless skinless walleyed pike fillet or 2 1/2 lbs other lean white-fleshed fish fillets salt & freshly ground black pepper
- 3/4 cup grated romano cheese
- 1 cup fine dry breadcrumb

green onion (optional)

#### Instructions

Spray a 15X10X1 baking pan with nonstick cooking spray.

In small saucepan, melt butter and stir in garlic and lemon juice. Rinse fillets. Cut into 6 servings, if necessary.

Sprinkle fish with Romano cheese and cover with bread crumbs. Drizzle the fish with any remaining garlic-lemon butter. (Fish may be prepared to this point, covered and refrigerated up to 1 hour).

Bake in 450 oven for 10 to 12 minutes or until flakes easily. Transfer fillets to warm serving platter and garnish with green onion
