#### MUCC Corner...Are We Our Own Worst Enemy?

Last week I posted a <u>DNR press release</u> announcing the publication of the first year of managing for CWD here in southcentral Michigan. I was surprised by a few responses to that report. But what stemmed out of that dialogue reminded me of a larger issue than just hunters who are not informed about the wildlife they manage - but the attacking that we as hunters personally do to each other. There are lots of posts about not supporting a company because of a stance they take on hunting, or complaints about anti-hunters, or even the decline of hunter numbers over time. But the real issue, and the heart of the problem I see - is that if we cannot be a uniformed 'largest armed army,' then divided we'll fall.

There are many different forms of wildlife management and recreation. We have hunting, fishing and trapping. All respected methods in their own rights. Each component has its own mess of controversy - amongst the ranks of hunters, trappers, and anglers. Rather than focusing on our areas of disagreement, why not focus on what we share to be true? I am most familiar with hunters, so I will stick to that topic.

In the hunting community I see barriers between crossbows and traditional archery, hound hunters and landowners, traditional deer management hunters and quality deer management hunters, conflicts between different species of hunting interest, private land and public land, northern and southern hunters, etc. Even the most 'like-minded' hunters have areas of drastic separation that seem to cause strong divisions.

Rather than be the cause of our own destruction, why can't we agree to disagree, or at least respect that we have different perspectives with different backgrounds and goals? Can we agree that our hunting community is part of who we are, being outdoors is vital, providing quality meat for our families is essential, following laws is mandatory, ethical hunting and harvest is required, and the existence of hunting is crucial for the future existence of the wild things we deeply care for?

I am grateful for the hunting community who has welcomed me in with open arms! My passion for managing habitat, sitting in my tree stand with my bow, following a dog searching for birds in the grasslands, walking a trap line and much more, is because of this community I love and respect so much. Let's show each other that side more often. Let's take part in celebrating accomplishments, questioning preconceptions, thoughtfully listening and considering what someone else has to share. Let us be the community I know we can be, putting our differences aside, and celebrating what is held common and dear - and protecting the future we desperately hope for. For each of us know, the void would be deep without this experience called 'hunting.'

# Heart Attack: First Aid

We are in the beginning stages of organizing a certified CPR and First Aid class that is American Heart Assoc. approved this Spring. We will keep you abreast of the time and date. This will count for USCG captain requirements and healthcare worker requirements.

#### By Mayo Clinic Staff

#### Someone having a heart attack may experience any or all of the following:

- Uncomfortable pressure, fullness or squeezing pain in the center of the chest
- Discomfort or pain spreading beyond the chest to the shoulders, neck, jaw, teeth, or one or both arms, or occasionally upper abdomen
- Shortness of breath
- Lightheadedness, dizziness, fainting
- Sweating
- Nausea
- A heart attack generally causes chest pain for more than 15 minutes, but it can also have no symptoms at all. Many people who experience a heart attack have warning signs hours, days or weeks in advance.

#### What to do if you or someone else may be having a heart attack

- **Call 911 or your local medical emergency number.** Don't ignore or attempt to tough out the symptoms of a heart attack for more than five minutes. If you don't have access to emergency medical services, have a neighbor or a friend drive you to the nearest hospital. Drive yourself only as a last resort, and realize that it places you and others at risk when you drive under these circumstances.
- **Chew and swallow an aspirin,** unless you are allergic to aspirin or have been told by your doctor never to take aspirin. But seek emergency help first, such as calling 911.
- **Take nitroglycerin,** if prescribed. If you think you're having a heart attack and your doctor has previously prescribed nitroglycerin for you, take it as directed. Do not take anyone else's nitroglycerin, because that could put you in more danger.
- Begin CPR if the person is unconscious. If you're with a person who might be having a heart attack and he or she is unconscious, tell the 911 dispatcher or another emergency medical specialist. You may be advised to begin cardiopulmonary resuscitation (CPR). If you haven't received CPR training, doctors recommend skipping mouth-to-mouth rescue breathing and performing only chest compressions (about 100 per minute). The dispatcher can instruct you in the proper procedures until help arrives.
- If an automated external defibrillator (AED) is available and the person is unconscious, begin CPR while the device is retrieved and set up. Attach the device and follow instructions that will be provided by the AED after it has evaluated the person's condition.

#### **Tagging Program**

During the month of May, each of us received a letter from the Conservation Department, which stated that some of us may get the opportunity to help in their tagging program.

Before any of us expected this opportunity, Dr. Williams came up with the tags, and has already instructed some of the Club members in how to do this work.

Many of you are already familiar with most of these men, but more important, many of you know their boats. This will be a great aid to this project because when any of you are near one of these fishermen with a hooked Muskie which you would like tagged and released, any one of these men will be glad to do the job. Under-sized fish are included in this tagging program and are just as important.

To briefly explain how this tagging is accomplished, we first must put the fish to sleep in a tank of water and a solution of dilute tricaine, which serves as an anaesthesia for fish. Then, with a special tool, a long yellow tag is inserted above the lateral line of the fish, about an inch back of its soft dorsal fin. This can also be seen in the photograph. It must be done carefully and correctly. All of the men chosen for this job have had a lot of experience catching Muskies, and were picked specifically for this reason. They are not by any means the only ones qualified in our Club to do this job, but only eight sets of this tagging equipment were available at this time. We are going to receive more of this equipment at a later date, when others will also be instructed.

All of us are again asked to release these fish, if caught, along with scale samples taken from the side of the fish about in the center. Mark down the tag number, of course, the length of the fish and location, as near as possible to the place it was caught. If it is legal, and you desire to keep the fish, then return the entire tag, scale samples and other information to the Conservation Department.

# Warning - To All Who Fish Canadian Waters For Muskie!

The Ontario Department of Lands and Forrests has recently adopted a get tough policy! Muskie fishermen are finding out that the Canadian fishing laws are being strictly enforced! If you are fishing in Canadian waters for Muskie, and use more than <u>one</u> rod per person, prepare to lose all but the one rod allowed. You will also be required to pay a fine, if you have too many rods in use. Warnings are NOT being given, so play it safe!

Your E ditor knows that fishermen (who use rods in excess of the one allowed perperson,) are being stopped by Conservation Officers, and all excess rods are confiscated. We know of a fisherman who was trolling with too many rods, and when stopped, turned over 4 rods, 4 reels, and \$13.50 to the Conservation Officer.

The MICHIGAN ONTARIO MUSKIE CLUB, will do all it can to try having this law amended. The amendment will (hopefully) allow the use of two rods per person. However, fellow members, this will take time; so until the law IS changed, fish with only one rod per person in Canadian waters, or be prepared to lose your rods and reels!

## A Great Guy

Mr. Muskie is the name of a boat piloted by one of the greatest sportsmen and Muskie fishermen around. We should all give this man a standing ovation when we see him, and a big pat on the back, (between the shoulders preferred). He was one of the group who formed our Club, and does not wish to commercialize or derive personal gain from what he does for the Club. When a special meeting of The MICHIGAN-ONTARIO MUSKIE CLUB comes up, and he has other commitments, he is the first to be at our Club's meeting, even if it puts a little extra pressure on him to be late for other meetings.

If you members were surprised at some of the prizes at our Derbies, you can thank Mr. Muskie, because he contacted the manufacturers himself, and requested these prizes for our Club.

However, after reading in the newspapers about the toll due to drowning and boat explosions over the past weekend, he felt it was necessary to remind our membership to always be on the alert to prevent a disaster within our membership.


Many factors contribute to an accident. One of the most prevalent among inboard owners, is explosion due to fumes in the bilge. During the Derby at Gassow's, a non-member's cruiser refueled, and when the engine was started, the unbelievable happened. The boat blew up! Fortunately, no one was hurt. Most of the occupants were on shore. Please close up all of the cabin windows, doors and hatches when you are gassing up, to prevent fumes from entering the cabin and bilges. Double check to be sure that no raw gasoline has overflowed into the bilges before you start the engine. Please be careful! We want all of our members to keep catching those Muskie.

Now, for a little dope on Muskie catching. The color of the baits used, depends on light and water conditions. I have found, (as have others,) that on a bright day with clear water, the gold colors for spoons are the best. On overcast days or on dirty water, silver colors are best.

The solid or jointed baits fall into the same general category. Dark days and dirty water call for dark baits. Bright days and dirty water call for in-between colored baits and bright days with clean water, call for light colored baits. If you follow these suggestions and do not catch anything, don't blame your Editor. Blame the Muskie, since he doesn't know which color is best and he may not bite just to be different. More next issue, and remember, PLAY IT SAFE!








## Help needed for Muskellunge tagging study

In order to understand the movements and behavior of Muskellunge and their associated fishery within the St. Clair-Detroit River System the Michigan Department of Natural Resources is launching a new study. The first step for this study begins this spring when a small number of Muskie (~20) will be tagged during the DNR's annual spring egg take in the Detroit River. Each fish will receive an internal acoustic tag which is automatically detected by listening stations deployed throughout the region. An ORANGE external FLOY tag will also be attached below the dorsal fin (see photos below). If you catch a tagged Muskie and plan to release it: please DO NOT remove the tag. Please record the tag number and contact Jan-Michael Hessenauer at (586) 465-4771 ext 35 or email: hessenaueri1@michigan.gov. If you harvest a tagged Muskie please remove the acoustic tag (approximate location shown below) and report the tag as per above. Reporting of tagged fish is greatly appreciated and will maximize the benefit of this study to the management of fisheries in the St. Clair-Detroit River System. Thank you!

# **Crispy Baked Walleye**

Serves 4 Crispy breaded fish without frying!

Ingredients 2 Eggs

- 1 Tablespoon water
- 1/3 cup dry bread crumbs
- 1/3 cup instant mashed potatoes
- 1/3 cup grated Parmesan cheese
- 1 teaspoon seasoned salt
- 4 (4 oz) walleye fillets Instructions
- 1. Preheat an oven to 450 degrees F (230 degrees C). Grease a baking sheet.
- 2. Beat the eggs and water together in a bowl until smooth; set aside. Combine the bread crumbs, potato flakes, and Parmesan cheese in a separate bowl with the seasoned salt until evenly mixed. Dip the walleye fillets into the beaten egg, then press into the bread crumb mixture. Place onto the prepared baking sheet.
- 3. Bake in the preheated oven until the fish is opaque in the center and flakes easily with a fork, 15 to 20 minutes

#### Aquatic Hitchhikers



Invasive aquatic animals and plants are spreading at alarming rates by hitching rides with anglers and boaters. Whenever boaters leave a body of water without cleaning their recreational equipment, they may

be transporting one of these harmful creatures from one lake or stream to another. A few invasive species are highlighted in this brochure.

ROUND GOBIES are bottom-dwelling fish that compete with native fish, like sculpins and log perch. They're also aggressive egg predators –

feeding on the eggs of other fish, such as smallmouth bass and walleye,



contributing to the potential decline of many valuable sport fish populations.

ASIAN CARP, including the highjumping silver carp and the voracious bighead carp, pose a serious threat to native species.



Canals and other connections to the Mississippi River Basin could allow Asian carp into the Great Lakes. Boaters and anglers can do their part to avoid accidentally transporting carp eggs, larvae, and young in bilge water, livewells or bait buckets. ZEBRA and QUAGGA MUSSELS feed extensively on algae and plankton, thereby disrupting the delicate balance of the entire aquatic ecosystem.

Just because they make the water clearer by eating plankton doesn't mean they're good for lakes! In addition to changing the food web, the filter-feeding invasives build up contaminants in their bodies, which

in turn, exposes other animals to higher levels of contaminants. They

have been known to attach onto and kill native species of mussels. While zebra mussels can colonize any hard object, quagga mussels are far more versatile. They can live in colder, deeper water and thrive on a sandy lake bottom.

EURASIAN WATERMILFOIL, PHRAGMITES AUSTRALIS and PURPLE LOOSESTRIFE are invasive aquatic plants that also endanger our waters and wetlands. While they may look harmless, these plants can crowd out native plants and take over large areas quickly. Milfoil, a submerged

plant, often gets wrapped around boat propellers. It's important to clean plants like Eurasian watermilfoil off of your boat and trailer because they can reproduce in new areas from a strand as little as two inches long.



#### Found Something Strange?

The Great Lakes Aquatic Non-indigenous Species Information System (GLANSIS) website is your one-stop portal for Great Lakes invaders. If you find an invasive species while boating or fishing, check GLANSIS first for:

- Identification information to verify if it is a native or non-native species.
- Fact sheets about invasive species impacts.
- Collection details: has this species been documented before in this body of water?
- Link to a reporting form to help scientists track the spread of aquatic non-native species.

Prevent transport of aquatic invasive species. Clean ALL recreational equipment.


BEFORE launching... BEFORE leaving:

- ✓ INSPECT watercraft, trailer and other equipment.
- REMOVE visible aquatic plants, zebra mussels other animals, and mud before leaving any water access.
- DRAIN water from boat, bilge and livewell by removing drain plug and opening all water draining devices. Regulations require this when leaving any body of water in Michigan.
- DISPOSE of unwanted bait (including minnows, fish parts, worms, and roe) in the trash.
- ✓ SPRAY/RINSE recreational equipment with high pressure and/or hot water (120°F/50°C or higher), OR
- ✓ DRY everything at least five days before going to other waters.
