Joe Pierce Memorial Derby

The first ever Joe Pierce Memorial Derby was held Sept. 13th & 14th at Lens gas dock in Emerald City Harbor. A special thanks goes out to Len for allowing us to have our tournament at his gas dock.

Even though hurricane Ike made fishing difficult, we managed to have a successful tournament. The crew of Impatient made it to the scales with little time to spare on Sunday. Keith Jones took first place with a MONSTER fish weighing in at 38.75 lbs., was 53 3/8" long and had a girth of 22". This fish is the third largest fish registered in the MOMC to be successfully released. GREAT JOB!!!! Second place went to Shelby Budzeak aboard Shelby Kristy. Her fish weighed in at 33.35 lbs, was 51 3/4" long, and had a girth of 21". It is great to see the junior members of our club get into the fishing action!! Richard Maison Jr. took third place with his fish weighing in at 32.55 lbs, with a length of 49 ½", and a girth of 22". Nice Job Downtime!!!

We also had two junior releases over the weekend. First went to a familiar junior angler of the club, Brendan Budzeak. His release was 52" long, caught at the Thames on a Dog Turd Wiley. Second place junior release went to Taylor Picarella aboard Gore-May with a 51 ½" length, caught at the Rusom on a brown and white Buck Tail.

I would like to point out that the top 3 registered fish from this weigh in were all released!!

Even though it was raining like cats and dogs we had a great turn out at the weigh in. If you weren't there you missed a great dinner from Fast Eddies. It was awesome!!! Thank you to Jason Allred and Tod Stanton for filling in as weigh master on Sunday.

Rule Reminder

Please remember the new rules:

2.3.2 – When M.O.M.C. Tournament Headquarters are closed, during scheduled tournament fishing hours, a current MOMC Board of Director or Derby Committee member <u>IS</u> permitted to perform Weigh Master duties for a MOMC member in good standing, at their discretion. This is done as a courtesy, in an effort to help those releasing their muskie for another day. A Board of Director is **NOT** allowed to register his/her own muskie, without another MOMC Board of Director present, who is **NOT** fishing on their team.

2.4.1 – The MOMC Tournament Scale **IS** an official MOMC Authorized weigh-In Station, and is recognized as such, at the discretion of any MOMC Board of Director, for the entire MOMC fishing season.

As an active member of the MOMC it is your duty to know and comply with the MOMC Rules and Regulations. This will make for enjoyable and satisfying fishing experiences.

5th Annual M.O.M.C. Perch Tournament

It's hard to believe the fall is already here. For the perch fisherman in the club, this is a favorite time of year.

The same rules will apply in this year's tournament. The tournament will be held @ Michigan Harbor on Sunday, October 19, 2008. A signup sheet will be available at www.lscmomc.com regarding this tournament. If the weather does not cooperate we will call the tournament Saturday evening and reschedule or refund the entry fees.

Perch Tournament Rules

- 1. Participants agree to accept all decisions by the four judge panel, which include: Brad Horton, Scott D'Eath, Dave Rybicki & Tim Adams.
- 2. The derby fishing stops promptly @ 2:00 PM on the 19th of October, 2008. All captains must be **ON** the Michigan Harbor Gas Dock no later than 2:30 PM. **This means** fish in hands and standing in the weigh in line on the dock. Any late comers are disqualified from weighing their fish. **NO EXCEPTIONS** !!!!
- 3. Only perch up to one (1) limit of 50 each counts toward the official registered catch of the vessel.
- 4. In the interest of conservation & preservation of the species, we limit the minimum size of all registered perch to 8" or larger. That would be 8" on a ruler scale not 8" on the Man scale.
- 5. The amount of cash prize is dependent on the total number of entries minus the total expense of the derby. The heaviest registered catch of 50 perch or fewer wins the grand prize. There will be a prize for the largest single perch by length. Pay outs will be for 1st, 2nd, & 3rd places.
- 6. All waters of Lake St. Clair as well as the waters of the Detroit & St. Clair Rivers are open to the derby.
- 7. Only the fish caught the day of the derby can be entered into the weigh in and the catch must be preserved on ice.
- 8. Only legal means of angling may be used to harvest the perch as identified by the <u>Michigan DNR & Ontario MNR.</u>

MOMC Derby Control will monitor channel 80 as the primary channel & channel 72 as the backup.
